Personal Statement

I have been a member of Council since 2007 and currently serve on the ICAEW Members and Commercial Board, having previously been Vice-Chairman of the Ethics Advisory Committee.

I serve on the main committee of the London Society of Chartered Accountants and am a past Chairman of the Central London Small Practitioner's Group where I regularly speak and host the monthly meetings.

In 1984, I set up as a sole practitioner after working with Deloittes and BDO having qualified in 1978 with Citroen Wells.

Currently, I am a senior partner of Munslows LLP, a five partner firm specialising in tax, private clients and SME family businesses.

I am experienced in corporate finance specialising in the listed small capital area and have served as a director of a number of AIM listed companies as well as a Family Office Board.

The profession is currently under pressure from many directions. We are fighting the FRP to retain audit regulation. The government and media are misrepresenting the accountancy profession as encouraging tax avoidance, together with threats of imposing greater regulatory burdens and potential tax penalties on the profession. Making Tax Digital is being pushed through by HMRC and government without adequate consultation time and consideration of the needs for small businesses and their agents to adapt to the new rules.

In such a rapidly changing environment I consider that my wide range of experience in both professional practice together with my experience as an AIM company director in working with auditors is invaluable in meeting these challenges. Accordingly I wish to continue representing the interests of members of ICAEW in a constructive manner, and to serve on Council on behalf of both the London members and members in general.

I was a partner at Arthur Andersen during the 1990s until the firm's demise in 2002. Since then, I have built a team focused on bringing financial and economic analysis to complex commercial, regulatory and legal problems. That team now operates in 10 countries around the world, and is part of FTI Consulting, a firm that includes many chartered accountants in most of the normal disciplines, with the exception of auditing.

My experience therefore includes both very large and very small firms. I have held, and hold, positions of global responsibility within those firms. Away from management responsibilities, I work regularly as an expert witness in International Arbitration and other types of dispute. In that role, I have seen first-hand the trust placed in our profession by the judiciary and the legal community.

I have experienced a period of exceptional growth in the breadth of services provided by Chartered Accountants, a function I believe of the reputation of the profession for independent and insightful analysis. In many ways that reputation for independence, and professional competence, is now being undermined - driven by a consolidation of the profession into a small group of elite firms - with a consequent rise in regulatory oversight.

The risk facing the profession is the slow erosion of public trust. The world, however, needs independent, objective and insightful financial analysis and reporting as much as ever. The profession needs to ensure that it continues to provide it. I would like to help to ensure that it does.
