The impact of our bursary and mentoring programmes

To date, the ICAEW Foundation *Changing Futures* bursary programme has supported 52 undergraduate students of accountancy and finance in universities across the UK, and in Hong Kong and Cyprus.

We are delighted to include reports from two of our students who have recently entered the world of work, as well as to hear of the interest a number of the students have in becoming chartered accountants.

Our *Building Futures* bursary programme, for students of new professional accountancy qualifications in Malawi, Ghana, Cambodia and Lesotho, has funded 120 bursaries since its creation a few years ago. In the past year we celebrated the qualification of the first students to qualify as ICA Ghana chartered accountants.

We are equally pleased to report on the success of our bespoke mentoring programme:

Mentoring Matters was designed and launched in the 2019 academic year for our UK bursary students and rolled out in conjunction with Deloitte. The programme aims to support each individual student's wellbeing and help them on their study journey, as well as offering them future career advice and guidance. Students have let us know how valuable and important mentoring has become to them and we are most grateful to the mentors who give generously of their time. This year an additional 14 mentors have volunteered and we have extended the programme to students who applied for but were unsuccessful in obtaining one of our bursaries.

Our activities are overseen by our recently refreshed Board of Trustees (Chartered Accountant Trustees) who also guide and steer our strategy. We especially thank them for their work and support during 2020.

BSc Accounting & Finance - 3rd year

I would like to first start by saying thank you for the ICAEW bursary, it helped me hugely during the pandemic as I had lost my job.

The pandemic has affected all of us, either at work or university. Most of our lecturers already gave us access to recorded lectures for each of the modules which made the transition to online teaching slightly less stressful. However, that was only the case for lectures and not tutorials which could not take place as the university was closed. I feel that I benefit more from tutorials as the group is smaller and it allows you to ask more questions and link more of your knowledge to practical questions.

During the exam period everything was online which caused strain on my eyes, however we were given extra time to complete the exam. It was a stressful period of time as I also faced some difficulties with my student accommodation, but all fixable and I'm just grateful that me and my family are healthy and well.

I have been back to university since September and at first it had felt strange with everything being online. I have had four modules this term; corporate finance, corporate strategy, business strategy & management and business strategy. I have also picked up another module to learn - Arabic - to develop my skills and to assist in future jobs, I feel like having more than one language is very useful.

In year 3, we are given a theme to write up our dissertation and I have picked the question: What are the impacts on diversifications and M&A accounting on the firm value? When I was first given my theme on diversification discount of firm value, I didn't know what to do and I was very confused because I didn't really know what this consisted of and didn't know much about the theme. However, since researching and reading more about the topic I am looking forward to doing my dissertation because it's challenging and will expand my knowledge in this area.

I have applied for several graduate jobs in the field of taxation and consulting for firms such as EY, Goldman Sachs, KPMG & Barclays. However, when applying for these jobs they had stated they would train you up for ACCA, although I would like to explore the option of doing the ICAEW training too.

I will be returning to university in the coming weeks and everything will be online, unless you choose to come in for only a few tutorial/dissertation meetings. I will be starting my dissertation in the first week of being back. I had nine themes given to me by our course officer and we had to pick the one we most wanted to the one we least wanted and hopefully we will find out our theme next week or the following week. I am looking forward to doing my dissertation and to just learning new things and expanding my knowledge.

MANCHESTER BUSINESS SCHOOL

I would like to start by saying thank you to the Foundation for the mentorship and funding I have been receiving. These have massively supported me through my studies in my second year.

After a successful first year, I wanted to challenge myself further in my ability to cope with a higher workload, so I decided to split my modules for the second year into 70 units in the first semester and 50 units in the second. Normally the split is required to be 60-60, but with the peace of mind I had from the funding I receive through this scholarship, I knew I could stretch myself further. Although it was a challenging semester, I was pleasantly surprised and proud of the outcome I received when our exam results came out. In one of the modules I had been struggling with the most (Financial Reporting and Accountability), I got 90% in the exam, and with my other six modules I got First in four and a high Second in the other two. I believe I was able to concentrate and focus on my studies to this degree as a result of having the ICAEW Foundation bursary, and for that I am very grateful.

Furthermore, thanks to the Foundation providing a mentor for their students, I was able to learn many things that have been pivotal in my career development and direction. From my communication and discussions with my mentor I was able to learn about some of the different routes and positions in the field of accounting, and although I was aware of these roles before it was very beneficial to get a higher level of depth and understanding.

For instance, my mentor - who is currently working as an external auditor - explained some of the day-to-day activities and challenges that come with the role, and she also advised me to explore other positions. From that takeaway I secured work experience with MIAA internal auditors, and as a result I was able to understand how broad the work of internal auditors could be, especially compared to external auditors where a higher focus is placed on the finances of



a company. It was interesting to know that internal auditors can even focus on areas like sustainability and health and safety processes.

Additionally, with the advice I received from my mentor I have also been able to get more work experience with GCC Accountants, where I am learning about other roles in accounting including how to prepare financial reports for businesses, administering payroll and providing tax services to clients. This work experience is also helping me to understand the material I am learning at university much better, as I am being exposed to how materials learnt are put into practice in the workplace.

Moreover, throughout the year I have been volunteering for a charity called the Widows Empowerment Trust, where I sometimes apply the knowledge I have gained through my accounting course to help with administration work. I also help with activities like fundraising events, such as those where I help customers that shop in stores like Tesco and Asda to pack their shopping, in the hope that they will donate to the charity. As a consequence of my dedication to this volunteering, both the CEO of the charity and The University of Manchester awarded me with a badge and a thank you card for my efforts, and I felt very proud of myself for that.

As a result of the different experiences I have had throughout my second year, I have been able to build upon my communication skills, teamwork and commercial awareness, and I believe I would not have had the opportunity to gain those experiences without the help of this scholarship. The funding also helped me with the transportation costs required while gaining these experiences.

Tam very thankful for this opportunity, and I hope that other students in situations like mine will also be able to get this kind of mentoring support to reach their full potential as excellent students and inspiring workers in the future.'

RECIPIENT OF THE BECKINGHAM BURSARY, MANCHESTER BUSINESS SCHOOL

A new year will always lead to new challenges, and I can conclude that this year has been more challenging compared to last year. Current global events have led to even more uncertainty and challenges. However, these challenging moments have persuaded me to be more innovative - whether it is in my academic projects or in my part-time work.

Upon reflecting on my academic studies, I conclude that I am satisfied with the grades I have achieved. I found the Principles of Taxation module interesting, and I particularly enjoyed the opportunity to participate in the UK tax system analysis group project. The project enabled me to advance my research on the UK tax system since discussing this topic at the PwC citizenship workshop last year, when I visited their Manchester office with the whole class and our lecturers. In the group project, the debate on ethics in the tax system was interesting and especially notable with regard to how tax rates affect the living standards of the country. I was satisfied with the grade I achieved for that project: 88%, which is a high First.

The Foundation of Finance B module was also notable as it has enabled me to learn how to effectively analyse investments. The assignment required me to approximate the risks and returns of portfolios through the use of databases such as Capital IQ and Fama French, and the skills and knowledge acquired from this project will enable me to understand how to effectively invest in stocks. Combining my accounting knowledge with company valuation, I now find it easier to identify whether a company's share price is under or overvalued. I look forward to profiting from this knowledge in the future.

Outside my studies, I have decided to support first year students and guide them with any issues they are facing. That's why I have decided to participate in the new BSc Accounting volunteer programme which enables second year students to coach first year students. My objective is to help them make the most out of their academic year, and especially to ensure they feel comfortable and motivated by understanding their perspective and being sympathetic. Currently, this communication is being done remotely due to the lockdown, but this has not been an issue since we are all comfortable communicating online.



Additionally, this volunteer opportunity enables me to apply for the HEA Associate Fellowship, which involves sending a detailed self-reflection on my experience coaching first year students. This qualification will be useful for me if I ever consider having a career in the education sector.

Also very helpful for my career has been ICAEW's recent partnership with Deloitte. Fortunately, I managed to join the Deloitte mentoring scheme through the ICAEW Foundation and have been paired with a mentor who is an assistant manager at the Deloitte London office. Being in contact with an ACA accountant has been really helpful, and I have managed to discuss many practical elements of accounting with my mentor. I am grateful to be able to participate in this scheme.

In terms of my long-term career objectives, I am currently aiming to acquire a spot on a placement programme. Unfortunately, one of the work placements I was in the process of acquiring got cancelled due to the current global event.

However, there are still opportunities available that may enable me to acquire a role, so I am hopeful. Ultimately, I am still aiming to become an ACA accountant, even though I have recently become interested in other areas in business. In the meantime, however, I have been working as a shop floor assistant with Asda since 2018. This role has been really important recently due to the lockdowns in the country, and the workload has increased significantly.

I would like to end by thanking you for your support and financial aid. It is difficult to express your impact in words. The scholarship funds have enabled me to acquire resources that I need for my studies, such as books and a laptop. My income from my part-time job would not be sufficient to provide the same level of support, which is why I and my family – and especially my mother – have been big supporters of your philanthropic work. I have completed my first year in university and overall, it has been a successful campaign. I have averaged 82.5% in completed modules, which amounts to a first, even achieving over 95% for one module.

Additionally, I have learnt more about the accounting profession as a whole, which is very beneficial to me because I aspire to be an accountant. As a result of this it puts me in a better position to pursue my goals once I leave university and this is due to the mentoring scheme ICAEW provides for me. For example, after talking with the mentor I discovered that there are several different paths you can go through to be a qualified accountant, such as becoming a management accountant where you help make key business decisions and explain the effect these will have, or going through another path such as audit which is financial accounting based, where you check company's financial statements. The mentor also explained to me the qualification process, which also helped a lot because it showed me the amount of work it takes to be an accountant and the time demands it has. This further enticed me in and as a result inspired me to work harder to achieve higher results, which paid off. Moreover, due to your scheme I learnt the kind of work that different sized firms do, resulting in me knowing early in my university life what kind of firm I want to work in, which has kept me be more focused and determined, hence resulting in achieving higher grades.

The main way in which ICAEW has helped my success through the past year is the bursary award it has provided. Due to the background I come from, the £4,000 I received helped me achieve what I did in my first year in university. This is because this money has helped me pay for a railcard and my train expenses, which have been quite expensive due to the distance I travel to reach the university every day. This has also helped me pay for food on the days I attend university. Additionally, it has allowed me to purchase the core textbooks for my modules, and without these I would not have been able to do additional practice, which is what helped me achieve what I did in the first year. Without the bursary I would not have been able to purchase these necessities, which would have adversely affected my results. This is because without receiving the bursary I would have had to get a job. As a result, it would make it more difficult for me to allocate enough time to my studies, because I will have another responsibility to account for. This would reduce the focus on my studies as well as reducing the amount of revision that it would have been possible for me to do.

'I fell in love with figures when I was at senior high school, so I enrolled at the Institute of Chartered Accountants, Ghana (ICAG) professional qualification programme, run by ICA Ghana,' says Bismark. That was in 2017.

He needed financial support to further his studies. Luckily he was able to apply for a loan through his employer. One year into his studies and shortly after he passed all his level 1 papers with distinction, he received a call from ICAG, recommending that he apply for an ICAEW Foundation bursary.

'I had got my scholarship, which meant that all my fees, including my tuition, annual subscription, study materials and examination costs would be covered, and would be backdated to November 2018.

When Samuel applied to university he chose two courses. He was accepted on the management education course but not the accounting one, which was his preference.

Once he had graduated from the College of Technology at the University of Education, Winneba, in 2017 he decided to study accountancy, albeit informally.

'I had no funds to pay for tuition so I just bought the books and studied for the four papers myself. I passed all my exams and graduated in November. I consider the bursary a gift, not only from ICAEW Foundation but also from God.'

Samuel gained the ICAEW Foundation bursary after he was judged the overall best student in quantitative techniques - one of the subjects he had taught himself. Trained Deloitte mentors who are ICAEW Chartered Accountants are participating in the programme. You will be assigned a mentor for the academic year (and beyond if you wish). The programme is an e-based one but you are also encouraged to meet your mentor if you can.
