PRESIDENT'S LETTER TO THE MEMBERSHIP

Dear Members

2024 was a year of evolution for ICAEW.

In a rapidly changing world, ICAEW, as a leader of the global accountancy profession, must continue to evolve to keep pace and it is doing so.

The fundamental reforms to modernise and strengthen our governance, which took place in late 2023, were fully settled during 2024. Under this new structure, Council remains responsible for ensuring that our Charter obligations are met and agreeing ICAEW's strategy. The oversight of management and the implementation of our strategy is now the clear responsibility of the new Board, which took office in June, and which reports to Council.

As President, I sit on both Board and Council but there is otherwise a clear delineation between the two allowing Council to hold the Board properly to account. It is to the great credit of Peter Wyman, as Chair of the Board, serving his first full year in post, that this change has proceeded so smoothly.

Alan Vallance joined us as Chief Executive in April 2024 and, with the new Board, we have been undertaking a refresh of our strategy, to ensure that ICAEW remains fit for the future and is able to continue to serve you and the wider society effectively. As part of this strategy review, we ran an all-member survey, and I thank everyone who responded – your input has been and remains crucial to this aim.

Many of the core elements of our strategy remain the same and several projects which formed part of that have been successfully implemented during the year. Principal among these are the Next Generation ACA qualification, announced in October, which has been extremely well received by firms and tutors alike, and the establishment of the Centre for Public Interest Audit (CPIA) in June as a policy and research institute to improve audit quality across the profession.

In parallel with this and the introduction of the new CPD requirements in 2023, we have rolled out a large number of new training programmes for members in areas such as sustainability, AI and ethics – all of which are key to the future of our profession.

Then there is our work on thought leadership: our involvement in influencing the development of standards and legislation and seeking to contribute to the success of economies worldwide. Like the work of our professional standards department, much of this goes on behind the scenes but is crucially important in retaining and enhancing our reputation.

Travelling around the UK and with visits overseas in my time as an Office Holder, I have been deeply impressed by how well ICAEW is respected.

For all of this, I need first to give credit to our staff. We are extremely fortunate to have such a diverse, knowledgeable and hard-working range of talent within our Institute. They form the bedrock on which everything else is built.

Our success also depends upon the generosity and goodwill of our global network of volunteers. Whether as Council members, faculty and committee members, advisory board members, or through contributions at roundtables, as authors, or in a host of other ways, you are critical to our work. On behalf of all our members therefore, I would like to extend my thanks to you. Without you, we would not be the body we are today.

It is difficult to know – particularly with changes in technology and global politics and continuing concerns over sustainability – what challenges lie ahead, but whatever they may be, I am confident that our Institute will continue to thrive in the years to come.

I am proud to have served as your President over the past year.

Why

These proposals will support ICAEW in delivering on its revised strategic outcomes and to meet the needs of its members. The proposed 2026 main rate is below what it would have been had it simply been increased with general inflation over the past five years. In addition, the earnings thresholds for the concessionary low and half rates have been increased by 10% to support members on lower incomes.
