#### **Personal introduction**

I think the key immediate issue affecting the profession is business continuity and with it, the security and availability of roles. Another challenge (rather than issue) is the growing adoption of technology and AI in businesses and the impact this will have on people in the accountancy profession. As a council member, I would hope to look into ways training, resources and tools are adapted so members' skills are kept up to date and relevant. An issue that is personal to me is the challenges of being a care giver whilst working and I would like to bring more support and resources for those who are in this position.

#### Communication with members in your constituency

I plan to engage with members in my constituency in methods that suit them in order to reach as many as I can whether it is in person, email, social media or the use of video conferencing tools. This year has seen the increased use of video calls and conferencing tools as a result of the pandemic and lockdown measures so I am sure this will continue in the coming years. Although I am someone who prefers to meet people in person or email someone rather than using calls, I will interact according to the preference of my constituents. I would like to hold small sessions where members can speak together to discuss any developments or issues and utilise people's experience to deliver a solution. I would also regularly arrange both formal and informal meetings so members will come to see me as someone they can turn to when they need support and gain more in their membership.
