How to reschedule or cancel an exam online




The following guide will take you through the process of how to reschedule or cancel your exam booking for any ICAEW CFAB or ACA Certificate Level exam.

You can cancel or reschedule an exam online up to 24 hours before you are due to sit to be eligible for a refund. Please note that if you have booked to sit an exam at a test centre and decide you want to sit your exam remotely, you will need to cancel your original exam booking and book the exam again as a new booking. If your exam was booked for you by your tuition provider or your employer you will need to contact them so that they can reschedule or cancel the exam on your behalf.

RESCHEDULING YOUR EXAM BOOKING

To reschedule your exam booking, go to access.icaew.com/pearsonvue and log in using your ICAEW log in details.

Click on the exam you wish to reschedule in your dashboard.

You will now see a summary of your booked exam.


On the right-hand side of the booking summary, click 'Reschedule' to amend the location, time or date of your exam.



You have an option here to amend the
date and time of your exam booking by
clicking 'Select Date'. To amend the date,
navigate to your required date and select
it. Then select the time you wish to sit
your exam.

You also have the option to change your exam centre by selecting 'Change Test Centers'.

Please skip step 5 if you are sitting an exam remotely or if you do not wish to change your test centre.



If you have selected to 'Change Test Centers', you will be presented with the option to enter the new location where you would like to sit your exam.

Tick the box next to the centre you want by clicking on it and then click 'Next'.


