



How to apply for credit for prior learning

If you have completed an academic qualification such as a Bachelor degree, Masters or a diploma, or have completed a professional qualification, you may be eligible to apply for exam credit towards the ICAEW CFAB or ACA qualification.

Credit isn't restricted to accounting or finance degrees, so if you have covered the ICAEW CFAB or ACA syllabus at university, college or as part of a professional qualification, your application will be considered. You can also claim exam credit if you are studying with us as a Level 4 or Level 7 apprenticeship student or if you have registered on the ICAEW Student Scheme (USS). This guide tells you how to apply.

GETTING STARTED

Before you apply for exam credits, also known as **credit for prior learning (CPL)**, there are a few things to remember:

- The first step is to **check our online directory** for all accredited educational institutions and professional bodies eligible for CPL.
- Don't worry if your qualification isn't listed, you can still apply.
- Before you apply for CPL, you must be registered as an ACA, ICAEW CFAB, USS, Level 4 or Level 7 apprenticeship student.
- If you have started an ACA training agreement or you have started either the Level 4 or Level 7 apprenticeship, be sure to check that your employer recognises CPL before you apply.
- Once you have sat an ICAEW CFAB or ACA exam, you cannot apply for credit for that particular module.

APPLY FOR CPL WITH A DIPLOMA, DEGREE OR MASTERS

If you have completed a diploma, Bachelor degree or Masters and would like to apply for CPL, you must have achieved a minimum mark of 50% in all modules relating to your application. Each module must have been assessed by at least 50% written exams and your degree transcript must be dated within the last **4-5 years**.

Check the online directory

If your university is listed within our directory, complete your **application online** and upload evidence of the modules and grades gained (this is usually a transcript), and evidence of the qualification award (this is usually a certificate).

If your university isn't listed within the directory, complete your **application online**, and the **assessment form**. This form will help us to determine whether the modules you have studied relate to the relevant qualification. Be sure to complete all sections of the assessment form which relate to the modules you are claiming credit against. You will need to send us evidence of the modules you have completed and grades (this can be a transcript), evidence of your award (for example, your certificate), and syllabuses and exam papers for each module relevant to your application.

APPLY FOR CPL WITH A PROFESSIONAL QUALIFICATION

Applying for CPL as a member of another professional body (for example, AAT and ACCA) can depend on your membership and whether you have completed certain exams.

Check the online directory

If your professional qualification is listed within our **directory**, complete your **application online** and upload your supporting documents to show the professional qualification you have achieved and your exam results. Once we have received your online application and supporting documents, your application is complete.

If your professional qualification isn't listed within our **directory**, we may not be able to award any exam credits at this time. We may, from time to time establish new agreements with professional bodies in countries around the world. YOUR SUPPORTING DOCUMENTS

If you experience any difficulties uploading your supporting documents you can email them to cpl@icaew.com and include your ICAEW student number in all correspondence. Please note that scanned copies of transcripts and certificates are acceptable, however we cannot accept screenshots of web publications or similar electronic notifications.

You can also send good-quality copies of your documents by post; however, this may delay your application:

If you choose to send your documents by post, you do so at your own risk, please do not send any payments or original documents.

CHECK YOUR STATUS

You can check the status of your CPL application online. Log in to our **website** via 'My Account' using your ICAEW student account details. If we are missing any documents, or require additional evidence from you, we will contact you by email. Your CPL application may take up to 14 days once all the necessary information has been submitted.

THE COSTS

The costs for applying for CPL are:

- £72 for each Certificate Level and ICAEW CFAB module; and
- £103 for each Professional Level module.

From 01 July 2022, the cost for applying for credit for prior learning will be:

- £75 for each Certificate Level and ICAEW CFAB module; and
- £105 for each Professional Level exam.

Credit is not available for the Advanced Level modules.

Please note that CPL costs are non-refundable.

Currently there is no charge for CPL for CCAB (ACCA, CIMA, CIPFA) and SOEL students and affiliates or, CICPA, ICAB, ICAP members. ACCA members are required to pay. **Find out more.**
