How to register as a student



If you're ready to register as an ACA student, this handy guide tells you how. Each step of the registration process is outlined for you, whether you are registering as a student in a training agreement, apprenticeship student, an independent student or a member of another professional body.

GET STARTED

To register as a student go to icaew.com/studentregistration

You will need to log in to our website to complete your registration. If you don't already have a username and password, please click on 'Register' to continue. Complete the short online form and choose your login username and password. An email confirming your username and password will be sent to you within 24 hours.

If you already have a username and password, go to icaew.com/studentregistration and log in.

Once you have logged in, you will need to select a qualification and student category. You will be studying for the ACA qualification. You then need to pick one of the following options:

ACA STUDENT IN A TRAINING AGREEMENT OR APPRENTICESHIP

Select this option if you have started, or have a date to start, an ACA training agreement or a Level 4 or Level 7 ACA apprenticeship. Click on 'View qualifications' and select ACA standard, Level 4 or Level 7 apprenticeship.

If you are starting a Level 4 or Level 7 apprenticeship, it is important you choose this from the options. If you select ACA standard by mistake, don't worry, just log back into icaew.com/studentregistration and re-register. Select Level 4 or Level 7 apprenticeship and follow the instructions on screen.

ACA INDEPENDENT STUDENT

If you are going to study the ACA independently and don't already have an ACA training agreement confirmed, choose this option.

Register here if you have started or have a date to start an ACA training agreement or an ACA Apprenticeship training agreement

Register here if you are going to study the ACA independently and don't have an ACA training agreement confirmed

ACA MEMBER OF A PROFESSIONAL BODY

Use this option if you are already a full member of ICAB, ICAI (India), ICAP, ICASL or ICPAK (independently). Click on 'View qualifications' and select the relevant member body from the options.

Here, you need to input your training office number - your employer or principal will give this to you. As soon as you enter the number, your employer's or principal's details will appear.

Now add the start and end date of your training agreement. If you have started your training agreement, you will only be able to go back four months when setting your start date. If you are completing this form after four months, you will need to claim credit for prior work experience, find out more at icaew.com/priorworkexperience

You will also be asked how you found out about ICAEW and the ACA qualification. If you wish, you can also complete the optional disability information, ethnic origin and social mobility sections before moving onto terms and conditions.

Here you will also add your employer reference number (ERN) and unique learner number (ULN), if you're registering as a Level 4 or Level 7 apprenticeship student. If you don't have these numbers to hand, you will need to add them to the apprenticeship portal within your ICAEW online training file before you apply for your end-point assessments.
