ELIGIBILITY CRITERIA

To earn the BFP designation, you must complete three core elements:

- 1 ICAEW Certificate in Finance,
 Accounting and Business (ICAEW
 CFAB): Complete six modules covering
 essential areas: Accounting, Business
 Technology and Finance, Assurance,
 Law, Management Information, and
 Principles of Taxation.
- 2 Ethics Learning Programme: An online programme that helps you apply ethical principles in real-life scenarios.
- 12 months of Work Experience: Gain practical experience in a business or finance role, applying your skills in a professional setting.

YOUR JOURNEY TO BFP

Follow these steps to achieve the designation:



STEP ONE

 \rightarrow

Enrol for the ICAEW CFAB or ensure you meet the eligibility criteria if you already hold relevant experience or qualifications.

STEP TWO

- Pass all six ICAEW CFAB modules (or apply for Credit Prior to Learning, except for the Accounting module, which must be passed)
- Complete the Ethics Learning Programme
- Accumulate 12 months of verified work experience

STEP THREE

 \rightarrow

- Submit your application along with evidence of your completed requirements.
- Pay the one-off registration fee of £25

MAINTAINING YOUR BFP STATUS:

Once you've achieved the BFP designation, you must:

- Uphold ICAEW's Code of Ethics in your professional work.
- Engage in Continuing Professional Development (CPD) to keep your skills up to date.
- Pay an annual subscription fee of £138 (£55 if your annual income is below £34,109 per annum).
