- 1. Under the Society's rules, nomination of candidates for election or re-election to the Management Committee at an Annual General Meeting must be made by notice in writing\*:
  - (a) signed by not less than THREE members of the District Society;
  - (b) received by the Hon. Sec. no later than 1 April preceding the date of the meeting, ie by 1 April 2024; and
  - (c) accompanied by confirmation in writing from each candidate of their willingness to serve if elected or re-elected.
- 2. Nominations can be made by letter to the address below or by email to the Society at Hon. Sec. of BBHSCA c/o <a href="kim.shield@icaew.com">kim.shield@icaew.com</a>
- 3. If more nominations are received than there are vacancies on the Management Committee, the vacancies will be filled by a ballot of those members eligible to vote who are present at the Annual General Meeting in person [unless a poll is demanded by not less than five members eligible to vote and present in person or by proxy]. The names of members elected or re-elected to serve a three-year term until May 2027 will be announced at the AGM.
- 4. Any member wishing to bring before the Annual General Meeting any motion not relating to the ordinary business of the Society may do so provided:-
  - (a) that notice in writing of the proposed motion be sent or given to the Hon. Sec. c/o kim.shield@icaew.com and be received no later than 1 April 2024; and
  - (b) that not less than five members entitled to vote at the Annual General Meeting shall have sent or given notice in writing to the Hon. Sec. (as above) not later than 7 April 2024 expressing their intention that the proposed motion should be brought before the Annual General Meeting; and
  - (c) that in the opinion of the President of the Society the proposed motion relates to matters affecting the Society or the accountancy profession.
- 5. The AGM will be held on Monday 13 May 2024 starting at 19:00. A formal notice will be issued to members of Beds, Bucks & Herts Society of Chartered Accountants in accordance with its rules.
