NEW ICAEW CPD REGULATIONS

ICAEW's CPD Regulations changed on 1 November 2023. Members and other professionals regulated by ICAEW need to complete a minimum number of CPD hours per year, some of which needs to be verifiable. The BBHSCA half day courses and Accountants in Business conference are classed as verifiable. Attending one of our half day courses could contribute 3hrs 15mins of verifiable CPD, so long as you can demonstrate that the content is relevant to your role.

FINANCIAL REPORTING UPDATE



Speaker: Andrew Mead BSc, MBA, FCA

Aims and objectives

A course designed to update you on recent developments in financial reporting, primarily aimed at UK GAAP, although any major development in IFRS will also be covered. It will brief you on changes to both FRS 102 and FRS 105 as well as topical and difficult issues. This will include ICAEW and FRC guidance.

Content

- Changes to FRS 102 and FRS 105 applicable for 2024 year ends.
- Update on the FRC's periodic review of UK GAAP which will have major impacts on both FRS 102 and FRS 105.
- Companies House update, including the implications of the Economic Crime and Corporate Transparency Act 2023.
- The latest guidance from the ICAEW and the FRC in relation to financial reporting.
- Topical issues for financial reporting for small and micro entities
- Brief overview of any major changes to IFRS for general application including the new IFRS 18.

This course will be relevant for preparers, auditors and users of UK GAAP financial statements, both those in practice and those who work in a finance function. The issues covered will apply to small and large companies.

TAX UPDATE AND HOT TOPICS!

Aims and objectives

To make sure delegates understand the key tax issues currently affecting their clients including high net worth individuals and OMBs, with particular emphasis on planning areas and the tax traps to avoid.

Content

- Tax developments in the last 12 months that affect individuals and OMBs, including those from Budgets and Finance Acts
- Key cases, particularly those from the Upper Tribunal and Higher courts
- Areas of major change, such as pensions and unincorporated businesses
- Key problem areas, such as directors' loan accounts, travel and subsistence, employment status, profit extraction
- Risk areas with the main capital taxes (BADR, PPR relief, BPR)

This course will be of benefit to anyone who deals with tax compliance for individuals or businesses, or who is involved in advising such clients on their tax affairs. Nontax specialists will also find it useful in keeping their tax knowledge up-to-date.

GETTING SMALLER AUDITS RIGHT



Speaker: Julia Penny

Aims and objectives

To ensure that auditors of smaller businesses understand, and can implement the current standards, with a focus on new or problematic areas.

Content

- The FRC revised Ethical Standard
- Root cause analysis as required by ISQM 1
- Partner appraisals and their role in quality and ISQM 1
- ISA 220 revised quality management at the engagement level
- ISA 315 revised on identifying and assessing the risks of material misstatements
- Sampling and other ways to collect evidence
- ISA 600 revised on auditing components and groups
- Going concern auditing and reporting and other topical issues

Target audience

All levels of staff and partners involved in audit work, but particularly audit partners, managers and supervisors. The course is aimed at those auditing less complex or smaller entities, although the topics will be relevant to those auditing larger entities it will not cover public interest entity requirements.

BUSINESSES IN TROUBLE: HELPING YOUR CLIENT



Speaker: Philip Ridgway CTA (Fellow), FABRP, Barrister

Aims and objectives

In times of economic crisis even some previously successful businesses are finding themselves in financial difficulty. One of the options available to them is to restructure in order to improve performance and financial efficiency, and, ultimately, survive. This talk highlights the various courses of action open to struggling businesses together with their tax implications.

Content

- The tax implications of restructuring a company's debt (mainly loan relationship rules), covering the rescheduling/release of debt and debt for equity swaps.
- The tax implications of insolvency proceedings (mainly corporation tax, group relief etc, but also CGT/ negligible value claims for shareholders).
- A high-level look at HMRC's guidance on the taxation of businesses.
- The tax implications of ring-fencing a financially burdensome business, company or division (CT/CGT, VAT/TOGC, SDLT), covering share/asset disposals, demergers and hive-down within groups

Any tax advisor concerned that some of their clients may struggle financially.

DEALING WITH CURRENTLY NON-DOMICILED INDIVIDUALS: THE NEW RULES AND TRANSITIONAL PROVISIONS



Speaker: Ros Martin

Aims and objectives

The aim of this course is to consider the new rules for currently non-domiciled individuals, to be introduced from April 2025. We will consider any planning opportunities that need to be considered for individuals already living in the UK and how it will impact those coming to the UK in the future.

Content

- The end of remittance basis and how foreign income will be taxed going forward
- The transitional provisions planning before and immediately after the changes
- The changes to overseas workday relief for internationally mobile employees
- The new rules for IHT
- Dealing with the transition to the new IHT rules for arrivers and leavers

Target audience

This is a significant change to the basis of the UK tax system and it will be important for advisers to understand the changes even if they do not currently have clients who will be affected. Anyone who deals with private client work will benefit from attending.
