## NEW ICAEW CPD REGULATIONS

ICAEW's CPD Regulations change on 1 November 2023. Members and other professionals regulated by ICAEW will need to complete a minimum number of CPD hours per year, some of which will need to be verifiable. The BBHSCA half day courses and Accountants in Business conference will be classed as verifiable. Attending one of our half day courses could contribute 3hrs 15mins of verifiable CPD, so long as you can demonstrate that the content is relevant to your role.
