CELEBRATING APPRENTICESHIPS DURING NATIONAL APPRENTICESHIP WEEK

This February saw the 15th annual National Apprenticeship Week with the theme of 'Build the future' for the second year. The week offered an excellent opportunity to celebrate the benefits apprenticeships bring to individuals, employers and society.

ATTRACT AND RETAIN STAFF WITH AN INTERNATIONALLY RECOGNISED QUALIFICATION





An ICAEW apprenticeship is a cost-effective way to grow your organisation. Students can start straight from school, as a graduate or you can opt to train existing staff, investing in your current workforce. By offering an ICAEW apprenticeship your organisation could benefit from increased productivity as the breadth of the ACA qualification is combined with structured workplace skills and behaviours training to create well-rounded ICAEW Chartered Accountants.

When discussing the benefits an apprentice can bring to an organisation Rob Young, Chief Financial Officer at Love Your Accountant said 'The ICAEW apprenticeship has led to an individual with the technical knowledge and skills required within the organisation.'

Organisations in England, across all sectors, can offer ACA training on an apprenticeship programme with the help of the apprenticeship levy. All UK employers with an annual pay bill of more than £3m are charged a levy of 0.5% which can be spent on an ICAEW finance and accounting apprenticeship. Those employers who do not meet this requirement have the option to make a 5% contribution to co-invest in an apprentice and the government will fund the remaining 95%.

ALL TOO FAMILIAR

All Too Familiar is a high-quality training film created by ICAEW in collaboration with HMRC which explores the degree of trust still placed in personal and professional relationships and whether enough scepticism is being used in the fight against economic crime.

'Perhaps I should introduce you to one of my restructuring partners?' was not a question that Jack Andrews, a partner in the major accountancy firm Nickel Turner LLP anticipated he'd have to ask longstanding client, Alex Murati.

Alex's once-booming Trivena restaurant chain was now struggling to survive. But Alex had another option. One of his cousins, Mika, wanted to invest and he'd run a successful restaurant chain in the family's home country. Mika was also an astute businessman

In a review of overheads, Jack was forced to admit that Trivena's payroll work could be done much cheaper elsewhere. Swallowing his disappointment, Jack was at least able to ensure that the payroll work went to King, Hunt & Maxwell LLP, a boutique accountancy outsourcing firm set up by his long-time college friend, Riley.

Mika's injection of money and expertise brought instant results. 'He must be the family's business guru' remarked Robyn, one of Jack's colleagues, when reviewing Trivena's management accounts. While it was unclear what had led to the change in fortunes, Jack was excited at the prospect of advising Mika's other businesses.

However, questions were being asked at King, Hunt & Maxwell LLP about changes at Trivena including its high staff turnover and changes to payroll. But these were put down to 'new management, new ideas'. After all, Jack had known Alex for years, Mika was 'family' and Riley trusted Jack's judgement and the quality of his client referrals ... so what could go wrong?

As with the previous ICAEW films, False Assurance (2015) and Without Question (2017), the latest release, All Too Familiar, challenges mindsets and provokes discussion. This time on the need for greater professional scepticism to help reduce the risk of economic crime, and in particular, money laundering.

The aim of this film is to help make accountants more aware of how they might inadvertently assist economic crime by providing services to businesses which are laundering money or engaged in other illegal activity. In the film, we see that longstanding relationships between accountancy firms and clients need to be reconsidered regularly, in response to changes in how clients generate income. Any change could easily be overlooked or dismissed due to trust in the relationship suppressing sceptical thinking.

As well as professional scepticism, All Too Familiar draws out many themes for discussion, such as:

- Can familiarity cloud a firm's judgement,
- When is the right time to disengage from a client, and
- What are a firm's professional responsibilities when engaging with law enforcement?

The film also examines the appropriate levels of Customer Due Diligence (CDD) and risk assessments for client relationships.

On Wednesday 22 June 2022 at Old Albanians in St Albans, BBH host a screening of the film. ICAEW Council Members Andrew Mead and John Sheehan will lead a Chatham House Rule discussion followed by a light supper to provide the opportunity to continue the discussion with your peers. WOMEN INSPIRING WOMEN

International Women's Day on 8 March is an opportunity to celebrate inspiring women in our profession. Elizabeth Wicks is one of Hillier Hopkins' many inspiring women, but one who has also achieved recognition for her work in inspiring others. Last year *Accountancy Age* named her as one of the UK's top 35 accountants under the age of 35 for her rapid career development, her role in advising schools, and for developing a network that empowers women.

Elizabeth joined Hillier Hopkins in 2010 as a graduate and quickly progressed through the ranks, becoming Director in April last year. She is a key member of the firm's dedicated Education team, leading audits for academy trusts across the South East.

In 2018, Elizabeth launched SHE Means Business, a brand new network aimed at inspiring women from all walks of business and at all stages of their career.

The motivation behind SHE Means Business comes from Elizabeth's own experiences of attending business events and realising that there were 'wonderful and knowledgeable people' missing from the table. Breakfast and after work events are difficult, if near impossible, for working parents so Elizabeth wanted to create something that 'was easy for everyone to attend'. SHE Means Business holds networking events during the working day on a bimonthly basis.

SHE Means Business looks to achieve more than being just another networking event. Elizabeth wanted to create events where attendees 'take away more than just business cards', so each event focuses on a keynote speaker.

Elizabeth explains: 'I am very mindful that when 'you know you don't know' something, it's easy to ask a question, but what

about when you 'don't know what you don't know'? My goal has always been that if just one person has a moment where they say 'ah ha, that's something I can do immediately to benefit my business' then I deem the event a success.'

SHE Means Business is now four years old and is valued by its regular members that have continued to meet and attract new members. Like most events throughout the pandemic, SHE Means Business successfully moved to online events and members continued to lunch and learn.

Her passion and ability to motivate and empower others also translates into the training of the next generation of Hiller Hopkins' auditors and she invests time in developing them. 'I love seeing the lightbulb moment in my graduates,' says Elizabeth. 'When we sit down and talk through a practical issue you can see that it doesn't really click but you keep discussing and suddenly it clicks, that's really satisfying.'

So who inspires Elizabeth? 'My clients inspire me every day with their passion and endeavour and of course my time as a judge for the Hertfordshire Chamber of Commerce's Inspiring Hertfordshire Awards. Meeting so many incredible entrepreneurs to help decide the winner of the prestigious Inspiring Business of the Year Award was a source of inspiration that keeps me energised and motivated to this day'.





THE KICKSTART SCHEME DELIVERS SURPRISING BONUS FOR HB ACCOUNTANTS

As part of the ICAEW's ongoing programme of increasing diversity in the profession, we look at one local firm's experience of using one of the Government's schemes, Kickstart.

Hertfordshire-based HB Accountants have long been advocates of apprenticeships and appreciate the importance of ensuring they are open to talent from all social backgrounds, so were intrigued to find out about the Kickstart scheme, back in September 2020. The scheme provided funding for employers to create jobs for 16-24 year-olds on Universal Credit and at risk of long term unemployment.

The firm heard about the Kickstart Scheme via a Government announcement and it immediately resonated.

HB Director, Karen Chase, explains more:

'We've employed apprentices for a number of years and are

passionate about supporting our local community. However, I've often wondered whether accountancy, as an industry, is doing a good enough job at appealing to students from a more diverse socioeconomic background. We saw the Kickstart scheme as a great way to give something back to the local area whilst supporting a young person. It provided an opportunity they may not have otherwise found and, ultimately, gave them valuable skills and experience that they could use to find a permanent role. We already had two apprentices and we felt that we had the resources and skills to support a third person.

The Kickstart application process was not the smoothest and there were a number of hoops to be jumped through to have our application accepted. Whilst we are experienced in regulatory filings, this was a whole different process! After three applications, we were finally accepted onto the scheme – we booked in interviews with a few young people and as soon as we met Carter we knew he would be a great fit and offered him a placement there and then. He was genuinely interested in accountancy, working within an office with similar-aged

people and was keen to make the most of the opportunity.' HB were delighted to welcome 18-year old Carter to their team in October 2021. Having recently secured his A Levels and decided to pursue training rather than heading off to university, he was looking for a role that would give him relevant experience whilst developing his natural numeracy skills.



I was so happy to secure work experience in a local business. Everyone is welcoming, helpful and supportive and I have quickly felt very comfortable. The work is enjoyable and I am pleased to learn new skills and earn some money. HB is a great place to work. The Kickstart Scheme has given me an insight into accountancy and office life and the knowledge that I am gaining will help me decide what to do next.

Karen went on to explain: 'We have found that the Kickstart Scheme has been great for our business on so many levels. We supported a local young person to gain valuable experience, skills and insights and have been able to deliver far more than we thought. Most of Carter's salary was covered by the scheme, so we have been able to invest more of our time and resources into training and development. We've also had the pleasure of meeting a fantastic person who has shown a real flair for accountancy. We took on two new apprentices in September, as part of our usual apprenticeship plan, but with Carter making such a positive impact, the directors decided to offer Carter an apprenticeship too, enabling HB to continue to support him in the next phase of his career.'

Unfortunately the Kickstart scheme closed to new applicants in December 2021, however, existing offers made to Kickstarters remain open until 31 March 2022.

Karen summed up by saying, 'We've had a really positive experience with Kickstart and we'll be looking to join in with the next initiative that enables us, as employers, to ensure that young people from all backgrounds are given opportunities within accountancy. It's been good for our business and good for our local area.'
