EXECUTIVE COMMITTEE

It really has been my great privilege to serve in the last year as President of the South Essex Society.

I was blessed in that my tenure has coincided with a return to "normality" after all the barriers to such that were imposed upon us during the pandemic. This has meant that the return to face-to-face events that started in the latter part of my predecessor's term of office has continued and it was, in particular, our great pleasure as a Society to be able to host a Charity Ball once again during the year.

The Society has a proud history of supporting the local membership in their roles and providing opportunities for learning and engagement both socially and professionally. One ongoing outcome of the pandemic is perhaps that members' needs and expectations on this front have changed in many ways, so it has often proved somewhat challenging for us to deliver opportunities that regularly attract sufficient interest. But we continue to strive towards evolving our offering and the input of the membership is invaluable on this front.

We held a number of online events during the year and also worked with other societies within our region to deliver larger events. A face-to-face business breakfast hosted jointly with FRP was very successful and notable for the number of business leaders in attendance, and a networking evening at a cricket match in Chelmsford was great fun. But the real highlights were the Business Summer Social and the aforementioned Charity Ball.

The Business Summer Social took place in Southend on a truly glorious sunny day in June. It was refreshing to have so many of our members and business partners mixing freely together after the limitations of the previous two summers and the day featured an exciting mix of talks and presentations, and the feedback was very good.

The Charity Ball made a very welcome return in November and our ICAEW Regional Executive, Eloise Puffett, truly amazed us all with the outcome of her efforts in producing a wonderful setting. The venue was truly beautiful. The evening was attended by Malcolm Bacchus, ICAEW Vice-President, and with sustainability being a core theme of the evening, Jo Roberts the CEO of The Wilderness Foundation, gave a presentation on their charitable work and I'm delighted that those in attendance showed their support financially. Fine food, student awards and a lot of laughter at the fun casino made this a truly great evening.

My role as President has generated a number of invites to events at ICAEW and other district societies around the country and I have been pleased to be able to attend these when I can. As well as promoting our own district, this has given me opportunities to take ideas from others as to how we can continue to deliver for our members.

The year has been distracted somewhat by the ongoing debate about the constitutional framework for district societies and possible boundary changes. This process is now hopefully at an end, and it is my belief that this will give us an opportunity to facilitate new and improved engagement with our members.

The District Society functions because of the help and support of some key ICAEW staff. In particular, the above-mentioned Eloise is the person who "gets things done", and she has certainly been an invaluable help to me in my role. Whilst still relatively new to the post, Eloise has built up an impressive network of partners and contacts and indeed continues to do so. This is often labour-intensive work, but the fruits of this are now starting to pay off.

I would also like to thank Harpreet Panesar who was the ICAEW Regional Director for London and the East. Harpreet worked tirelessly with us and brought great passion and humour to her role but has now moved on to a new role within ICAEW. I am pleased, however, to again welcome her replacement, Meghan Doyle, who is equally amiable and hard-working and who has certainly hit the ground running. We are truly fortunate to have such talented people working alongside us.

Our committee remains grateful to our Treasurer, Duncan Sheekey for his continued work and Amrita Ghosh who has been our Council member for South Essex at the ICAEW. From this year, South Essex is now entitled to have two Council members representing us, and I am pleased to welcome our new Council member, Neil Campbell, who becomes our second Council member from the end of May.

Finally, I would like to thank all my fellow Committee members for their good work and support during the year. Unfortunately, we did not have a Deputy President or Vice-President during the year and so I would particularly like to take this opportunity to thank two of my predecessors, David Belbin, and Simon Medcalf, for always being available to offer me valuable comment and advice when needed.

TREASURER'S REPORT

Most of our events this year have continued to be held virtually through Zoom and we continue to promote the ICAEW Essentials CPD Scheme to provide our Courses. The Society receives a small commission for each booking by our members. We have restarted having live events which included the Business Summer Social in Southend which was well supported. In the Autumn we had the Annual Ball which enabled our Membership to meet indoors in person for the first time since Covid restrictions. We receive a Grant from ICAEW which was used to help finance the cost of the event – although it did still run at deficit. This will hopefully continue to be our flagship event.

The Society has reported a modest deficit for the year of £ 587. There was virtually no expenditure incurred in the year.

The Society continues to put on a variety of events either business or social for the students, members, and retired members in an effort to keep all involved in the District Society. Following the closure of the SWEG Town Group the remaining Funds were transferred to SESCA to hold. These funds have been ring-fenced and the Committee agreed that these funds should be used to support members or events in the South-West Essex area.

The Society is in a good financial position which has been built up over several years. The Committee continues to seek activities that will be of interest and value for all members and has in place funding to cover such activities.

The Bookkeeping team in Milton Keynes carry out an excellent service in maintain the Society accounts and I am grateful for their continued support as well as Eloise keeping us organised in South Essex.
