Election Address

An election address containing more than one hundred and fifty words cannot be included in the election ballot paper.

The full name of the candidate, degree and qualifications, date of admittance to the ICAEW and the company, firm or employment need to be specified in the space provided on the face of the form. These details do not count as part of the 150 word description and should not be repeated in the personal description.

The nomination paper, with support from seven members of the Society, must be uploaded to the personal Sharefile folder by the close of business on Friday 22 April 2022.
