## NOTES TO THE ACCOUNTS YEAR ENDED 31 DECEMBER 2021

### 1. Accounting policies

These accounts have been pepared in accordance with the historical cost convention and applicable accounting standards. Income and expenditure have been accounted for on the accruals basis.

### 2. Surplus on meetings and events

Unlike 2020 there were no face to face events in the year and the deficit relates to the direct costs of each event. In 2020 the income from this source was £7,982, the expenditure was £5,623 leading to the surplus of £2,349.

#### 3. Prizes

In 2020 the prizes were funded from the annual surplus. In 2021 they have been funded from the specific reserve.

### 6. Reserves

The reserves held at 30 June 2001 were ring fenced to be used for members in the District. No events took place in either 2020 or 2021 justifying the. Use of this reserve which therefore remains unchanged.

2021 saw the 150th anniversary of the founding of the Society. The committee resolved that it was appropriate to earmark up to £10,000 for activities marking that event in ways that would propel the Society into the future. Due to the Covid epidemic no events were held but 4 are already planned for 2022.

There are discussions currently taking place with ICAEW about the ongoing role of District Socities. With that uncetainty and the need to review the way in which we deliver our programmes post covid, no change has been proposed in the reserves policy but it has been reviewed to ensure it remains appropriate.
