About Northern Society of Chartered Accountants

Northern Society of Chartered Accountants (NorSCA) was founded on 31 July 1882 with its inaugural meeting in Newcastle upon Tyne. The Society was established to support and encourage chartered accountants in the north of England to act in the public interest and to enhance their professional knowledge.

The Society was founded only two years after the formation of ICAEW (the Institute of Chartered Accountants in England and Wales) which was formed 11 May 1880 when the founding societies of Liverpool, Manchester, London and Sheffield agreed to form a national organisation.

Today Northern Society is a membership body for circa 4,000 ICAEW Chartered Accountants and ACA students who work across business & the finance profession in the North East, Teesside, North Yorkshire and Cumbria.

We have been at the heart of northern business for 140 years.



As well as promoting northern business we support our members through a programme of locally delivered training, networking and social events. The networking events included a popular mix of soft skills and social events. Details of upcoming events can be found at norsca.co.uk/events

FINANCES

The financial results for Northern Society in 2021 is one of these rare things - a Covid bonus. For the second successive year the society can report a significant surplus for the year, in respect of the year to 31 December 2021 we saw £10,684 transferred to our Accumulated Fund.

So whilst our “Covid Presidents” may have had a disappointing two years, the Society has been able to increase its reserves by £19,500. We are sure they will take great solace from this.

Looking at the 2021 Balance sheet the increase in Net Assets is down to the accumulation of cash in the bank and the more efficient collection of debts. The VAT payable for Q4 means the current asset of 2020 is a current liability this year, there is also a small increase in accruals. The total picture, of course, shows an increase in total assets equal to the surplus for the year of £10,684

The notes reflect the minimal change in activities, 2021 being the second year adversely affected by covid restrictions on face-to-face activity. No change to accommodation costs and only one printed communication to members - the autumn courses booklet with a short preface from the President. We remain very grateful to the unpaid volunteers who kept the web site updated to facilitate the promotion and booking of courses held on-line. Communication costs reduced by just over £1,500.

Towards the end of the year ICAEW did hold an Office Holders’ conference so travelling expenses were increased compared to 2020. The Society also bit the bullet and, albeit reluctantly, held the Prizegiving events for the 2019 and the 2020 exam qualified students as virtual events in 2021. Whilst this avoided the usual heavy cost of our face-to-face prizegiving events, there was expenditure on prize vouchers for the successful students who attended their event. Administration costs increased by just over £400.

Face to face events and courses, of course, hardly took place in 2021, and the appeal of CPD on-line had waned considerably as screen fatigue as well as the continued absence of new tax regulations meant our programme was a hard sell.

This is reflected in the outturn of the CPD courses – many posting a small loss as low numbers failed to cover the speaker and IT facilitator costs. Thankfully however some, in particular the Spring Tax and Audit Updates, the Finance Act 2021 and the Making Tax Digital courses were well supported and not only covered the less popular topics but contributed to a net surplus of just over £5,500. To this is added commission from Mercia (generously increased to pre-Covid levels) of £6,000 and a modest increase from ICAEW for their courses at £2,210.

All said, the Society's finances are in good repair, and as long as events are planned to break even and our members continue to support CPD courses we are well placed for the future. The Treasurers, Therese McCollam and Keith Proudfoot, would like to note their thanks for the support received from Joanne Lucking, the ICAEW District Accounts Team, and Colin Hutson Accounting in helping them to carry out their duties.

COMMUNICATING WITH MEMBERS

Northern Society usually aims to communicate with its members on a regular basis across the year in order to make members aware of new developments; inform them of upcoming courses and events which may be of interest and to obtain members' views on topical issues. This allows the Society to reflect the views of chartered accountants across the North East and Cumbria, both locally and at national level with ICAEW.

The usual schedule of production and distribution of our magazine, which includes the courses and events offer, normally represents one of the Society's largest financial outgoings. Whilst your President is keen to continue to invest in hard copy communications we continue to review different communication channels available to us rather than just relying on the hard copy magazine being made available in printed form.

The Northern Society launched its website norsca.co.uk in March 2014 to provide a channel for members to find out quickly and easily details of courses and events as well as a way to disseminate news more quickly. The Northern Society website also brings together the former NCASS website onto a single integrated platform which further demonstrates the strong links with our younger member group. The website was designed to be easy to navigate and with 'responsive design' content is formatted for optimal viewing whether using a desktop PC, tablet, iPad, iPhone or Android device. Each CPD course and event on norsca.co.uk is accompanied by a 'click-through' button to book online at icaew.com.

The Society continued to publish its *NorSCA News* magazine and which was published only once this year and distributed by post to all members who have indicated in their ICAEW member preferences that they wish to receive local communications. Whilst this year's edition was a much shorter version, the magazine's intention remains to keep members in touch with local news and events, with a focus on member activities. If you do not regularly receive this in hard copy please ensure that you have selected to receive '*Regional updates – news, course and networking in your area*' in your member preferences at icaew.com/preferences

The Society has also continued to make use of social media communication channels including Twitter (@ICAEW_NorSCA) and LinkedIn Groups to communicate with members. Members who have a profile on LinkedIn can join the Northern Society LinkedIn Group as well as sub-groups for Tyne & Wear, Teesside, Cumberland and NCASS.

COURSES AND CONTINUING PROFESSIONAL DEVELOPMENT

The Northern Society and its branches continue to provide a varied and extensive courses programme to assist members in fulfilling their CPD requirements. During 2021 due to the pandemic and resulting changes in how delegates wish to participate, the course offering to members has been adapted accordingly. The Society was unable to hold its successful Residential Course at Redworth Hall (our General Practitioner weekend conference) due to COVID restrictions. During the year the society held 11 (2020: 13) events attended by 307 (2020: 404) participants.

We continue to be one of the most active providers of local CPD courses for accountants in our area. Through proactive forward planning we remain successful in attracting high quality speakers to present topics to members in the North East and Cumbria. These have included

regular updates on tax, accounting and audit issues. We are always pleased to receive suggestions of topics for future courses from members.

Due to the ongoing uncertainty with the COVID-19 pandemic it was decided that the annual dinner in October would not take place again this year but a more informal Summer barbecue will be held on Thursday 9 June at South Northumberland Cricket Club in Gosforth. The 2022 annual dinner will take place on Friday 14 October, at The Grand Hotel, Gosforth Park.

MEMBER SUPPORT

Our member support contacts provide practical support and assistance, in an entirely confidential way, to members with problems. Diane Cartwright and Doug Kinsey currently act as Support Members.

CHARTERED ACCOUNTANTS BENEVOLENT ASSOCIATION (caba)

Keith Proudfoot and Les Hodgson are the Liaison Officers between the Northern Society and caba whose purpose is to assist current and former ICAEW Chartered Accountants and their families in both practical and financial ways where necessary.

If any members of the Society are aware of any member, former member or their immediate family in our district, or beyond, who might be in need of some help from caba then please inform Keith Proudfoot or Les Hodgson directly. WORKING WITH OTHER PROFESSIONAL BODIES

The Northern Society, through its Office Holders, aims to maintain contact with representatives of other business and professional bodies. These meetings provide opportunities to discuss matters of mutual interest concerning our professional lives and relationships at a local level and to promote the work of chartered accountants.

RECRUITMENT, EDUCATION & TRAINING

The annual prize giving ceremony in May, which recognises the achievements of local and national prize-winners from the Northern Society area and all those who have passed their ICAEW Advanced Level exams during the preceding year has become an established part of our calendar. COVID-19 forced the society to turn the events into a virtual celebration for those that were exam qualified in 2020 and 2021.

Careers fairs continue to be held at local universities, albeit virtually at the moment. Members both in practice and in business and younger members with recent first-hand experience of recruitment, education and training are encouraged to provide on-going assistance – please contact Joanne Lucking for more information.
