

ICAEW Scotland Annual Report 2022/23

INTRODUCTION

The last 12 months have been a challenging time for most with the on-going impact of the postpandemic phase and the continuing geo-political issues with the invasion of Ukraine. Both factors have fed into heightened cost of living and cost of doing business challenges. Against that backdrop, we have sought to keep our focus on supporting and engaging ICAEW members in Scotland.

It has been a time where most of our events have remained in the virtual environment (although there have been occasional physical events) and I have been delighted with the work undertaken by the ICAEW Scotland team to help provide relevant and engaging content and events. Our continuing key strategic themes are aligned to those of ICAEW, namely:

- Help to achieve the Sustainable Development Goals
- Strengthen trust in ICAEW Chartered Accountants and the wider profession
- Master technology and data
- Support the transformation of trade and the economy
- Strengthen the profession by attracting talent and building diversity.

During the year, we continued to develop the sub-group ways of working, and we were delighted with the interest and energy around those. Most obviously, the Sustainability group have been particularly active. Other groups in Technology, Women in Finance, and more recently our Young Member and Trainee Group have started to move the agenda forward as well.

There are three key areas at ICAEW reflecting the strategic aims and some of the events in this area have been:

BELONGING AND SUPPORTING

- As mentioned, we have continued to develop the reach of our virtual events to engage members more broadly across Scotland.
- We had a strategy day with ICAEW Scotland Committee, producing some great thoughts for the Committee (now Board) to pick up moving forward.
- Practice forum sessions, including with the ICAEW Practice lead, were again focused on small practitioners, where support is often the most valued.
- There was a further sustainability case study with Egg lighting, a 'green business' success story.
- ESG Reporting: strategic window dressing or value accretive? Simon Lloyd, a member of the ICAEW Scotland Sustainability Group, was in conversation with Tim Purcell, a corporate responsibility and corporate governance adviser.

- There was a series looking at the impact of SDGs on business covering biosphere / society / economy – Fran van Dijk (One Stone Advisors) and Simon Lloyd (ICAEW Scotland Sustainability Group) explored SDGs in relation to key sectors in Scotland, with an emphasis on innovation and opportunity.
- There were a number of Finance Director and Women in Business insight group discussions.
- We held a food and drink sector webinar with James Withers, (then) CEO Scotland Food and Drink; Tom Castledine, FD Famous Grouse; and Stella Morse, Partner, Inverleith and Board member Eden Mill.
- Technology roundtables included a session highlighting the latest developments in cyber security and how best to protect your business and explored how trust is key to the sustainability of a payment system. Also, separately, the power of AI for accountants exploring how finance and accounting professionals can practically embrace artificial intelligence.
- There was an in-person retired members' event at St Cecilia's music museum, Edinburgh.
- Carl Bayley presented on the UK budget impact and likely Scottish response for practitioners and those in business.
- Julia Penny (ICAEW President) attended our young members and student's roundtable on career development, a sustainability breakfast (funding for SMEs) and our festive drinks and networking event, which also explored the theme of trust in the profession.
- There were also leadership conversations focussing on the energy sector and charity sector.

REPUTATION AND INFLUENCE

- Member opportunities to input to wider ICAEW consultations including the Revenue Scotland additional dwelling consultation, and UK Government Payment and Cashflow Review and the Small Business Commissioner Statutory Review.
- We hosted a trust in the profession and our political system roundtable: in Edinburgh, with Iain Wright (ICAEW Managing Director, Reputation and influence) and Ian Murray MP (shadow Secretary of State for Scotland).
- Business Confidence Monitor (BCM) quarterly press coverage was again strong, and we held events with presentations from CBI Scotland, Scottish National Investment Bank; and a couple of Economic Summits (including with Hew Pill, Chief Economist at the Bank of England).
- Bank of England roundtables with Iain Duff were again well received.
- Collaboratively, we held a funding for business event (with Northern as part of BBB finance week) with input from local women-led angel investors, Mint Ventures amongst others.
- We supported the screening of 'All too familiar' film with a viewing for practice members.
- Members met Philip Nicol-Gent, ICAEW Regulatory Board Chair.

EDUCATION AND TRAINING

- We continue to support our Business Development Manager, Sally Gallery's work around links with FE colleges and access to the profession. We were delighted to be able to support and help raise awareness of ICAEW's campaign in Scotland (mid-Aug to end-Sep) promoting routes to the qualification (FE/HN pathway and diversity), with an employer webinar at end of campaign.
- We were also pleased to be able to identify two local trainees to represent students in Scotland on ICAEW's Student Council, and to include them in our activity planning with young members to grow a local support network: one the many outcomes from our roundtable with the ICAEW President, Julia Penny, in December.

• We were delighted that Sally was also able to join our committee strategy day and opportunity to collaborate and explore how to better support the varied and dispersed group of students in Scotland amongst other initiatives.

So, there has been a lot happening!

As we move forward into the upcoming year, we will be keen to continue our support for members, conscious that the challenges out there can create challenge at a personal level.

Another important vote of thanks goes to Gillian Woolman who, after almost 14 years, is stepping down from chairing the ICAEW Scotland Strategy Board. Gillian was one of the original champions and founding member of the ICAEW members in Scotland group and is another strong supporter of our other work.

Finally, I would like to extend my thanks to the ICAEW Scotland team and my fellow committee members. Thanks also to everyone involved in leading activities and new ideas during these difficult times.
