#### REGIONAL SUSTAINABILITY GROUP UPDATE

The first half of the year has been a busy one for the Regional Sustainability Group. Here's what's been happening and what to look out for in the months ahead.

February webinar: the Sustainability Group hosted a fascinating and extremely informative interview with Chris Stark from the Climate Change Committee looking at the key outcomes from COP26 and finding out his view on the most important changes that business could make to support the UK's Net Zero targets. A 20 minute excerpt of the full interview is available to watch on demand at icaew.com/technical/sustainability/ climate-hub/climate-for-smes

March webinar: this focused on carbonoffsetting. The key speakers explained theory and terminology of offsetting and its role in the journey to Net Zero, followed by a case study of Riverford Organic Farmers strategy, decision making and research to find suitable offsetting partners.

May webinar: The Circular Economy was the topic in May. We were joined by specialist speakers from the University of Exeter and the consulting sector for an explanation of the circular economy concept and examples of how companies have used it in their businesses. Attendees were able to ask questions to the specialist specific to their organisations.

June open discussion: The Sustainability Group facilitated a virtual open discussion group for attendees to bring their sustainability challenges and successes. Sustainability reporting was the

core topic and discussions around the emerging responsibilities of company directors for sustainability reporting and what Non-Executive Directors should be asking and how to use their role to influence sustainability strategy and direction were raised.

#### Coming up

September: This webinar will be about Green Finance - join us to explore the green finance and funding landscape and understand what loan providers might start requiring around climate risk reporting. We'll also be highlighting the targeted funding available to businesses looking to undertake the main decarbonisation activities.

October: We'll be looking at the training and courses available to individuals and businesses to develop sustainability knowledge and the skills for analysing and measuring sustainability metrics in business.

November: We'll be facilitating a virtual open discussion group for members following COP27 and the ICAEW Climate Summit.

#### SUSTAINABILITY TERMINOLOGY

Net zero GHG: the amount of all greenhouse gases (GHGs) - such as carbon dioxide, methane or sulphur dioxide - that are removed from the atmosphere being equal to those emitted by human activity.

Carbon neutral: the amount of carbon being removed from the atmosphere being equal to the carbon emitted This term means that emissions have been compensated but not reduced and does not necessarily include other types of greenhouse gases.

decarbonisation: measures that companies take to prevent, reduce, or eliminate sources of GHG emissions within their value chain.

Physical carbon accounting: the method of measuring both the direct and indirect carbon emissions of a company's or country's industrial activities into the Earth's atmosphere, also referred to as a greenhouse gas (GHG) inventory.

Financial carbon accounting: aims to give the carbon produced and absorbed a financial market value

The individual competition was won by **Jerry Winter**, with 39 points, just


ahead of Frank Stone (Maynard Johns) and James Clarke, who finished with 45 points (Frank winning on countback).

The ACA – opportunity to find out more:

Making an informed decision about which professional finance qualification is right for an individual is so important for their long-term careers and the organisations they work in. Therefore, I run monthly webinars to introduce both interested trainees and their employers to the ICAEW ACA Qualification.

The ICAEW chartered accountancy qualification, the ACA, is one of the most advanced learning and professional development programmes available. Its integrated components provide an in-depth understanding across accountancy, finance and business. Combined, they help build the technical knowledge, professional skills and practical experience needed to become an ICAEW Chartered Accountant. This qualification can be completed as a Level 7 apprenticeship.

If you/any of your colleagues or contacts would be interested in finding out more about the ACA qualification, then you are welcome to attend a virtual session where I will explain the ACA qualification, which is designed to suit those working in management and commercial accounting, statutory accounting and/or assurance type roles. I will cover the entry requirements and progression opportunities from prior qualifications such as AAT. We will also explore the flexible local training provisions available both online and in person.

#### **ANNUAL DINNER 2022**



In April the ICAEW South West annual dinner was hosted in Sandy Park, home of Exeter Chiefs. Our guest speaker was Ben Mee, the owner of Dartmoor Zoo, who wrote the 2008 book *We Bought a Zoo*, which documented his discovery of a dilapidated country house with numerous wild animals roaming the grounds and his determination to save them from being destroyed. In 2012 his story was made into a film starring Matt Damon and Scarlett Johansson. Ben entertained the audience with his amusing anecdotes about his struggles

to save the zoo, obtain funding and working with Hollywood to make the film. Dartmoor zoo also works with people with depression, PTSD and social anxiety. Afterwards he generously stayed on to chat to members.

The dinner was also attended by ICAEW President, Will Brooks, who gave attendees an update on developments at ICAEW.

Kerry Bidewell from Plymouth Children in Poverty gave a short presentation about their work to improve the life outcomes of young people in the city, where, in some wards, poverty levels are in excess of 35%. We managed to raise £760 for them through the generous donations at the dinner.

The dinner was preceded by an exam qualified reception attended where Will Brooks presented scrolls to 30 of our local graduates, of whom 21 stayed for the dinner.

#### INTERNATIONAL SUSTAINABILITY STANDARDS BOARD

In November 2021 the IFRS announced the creation of the International Sustainability Standards Board (ISSB) as a standard-setting body. The ISSB sits alongside the IFRS's International Accounting Standards Board (IASB) with a remit to create and develop internationally consistent and comparable sustainability-related financial reporting standards.

The difference in the standards from these two Boards are described by the IFRS as: 'IFRS Accounting Standards set out how a company prepares its financial statements. IFRS Sustainability Disclosure Standards set out how a company discloses information about sustainability-related factors that may help or hinder a company in creating value.'

The ISSB is building on existing sustainability reporting frameworks and standards, consolidating both the Climate Disclosure Standards Board and Value Reporting Framework (which itself brought together the Integrated Reporting Framework and Sustainability Accounting Standards Board (SASB) Standards).

In March 2022 the ISSB released its first draft standards for public comment:

- IFRS S1 General Requirements for Disclosure of Sustainability-Related Financial Information
- IFRS S2 Climate-Related Disclosures

Public comment closed on 29 July 2022 and the Board hopes to complete both standards by the end of 2022.

#### What does this mean for regulatory obligations?

The standards themselves will not create new regulatory obligations – it will be down to individual jurisdictions and regulatory bodies to adopt and include the standards for them to become mandatory reporting requirements. In the meantime, the standards will affect the expectations of stakeholders, investors and supply chains. These groups are increasingly looking for more consistency and clarity over Environmental, Social and Governance aspects of the businesses that they choose to partner and an understanding of the risks and opportunities that sustainability and climate will have on a business's value over time.

In April this year the UK became the world's first jurisdiction to mandate TCFD-aligned disclosures for its largest businesses. In May, Debbie Crawshawe, accounting expert at the Department for Business, Energy and Industrial Strategy (BEIS) indicated that the government will look to introduce a similar mandate on the use of UK-adopted international sustainability standards by 'certain economically significant entities'. This statement is supported by the UK Government's *Greening Finance: A Roadmap to Sustainable Investing* publication which indicates that it expects to use the ISSB standards when they become available.
