


AN EMPLOYER'S GUIDE TO ICAEW APPRENTICESHIPS



WHY OFFER AN APPRENTICESHIP WITH ICAEW?

Organisations in England, across all sectors, can offer ACA training on an apprenticeship programme with the help of the apprenticeship levy. Whether you make use of your own levy funds or benefit from up to 95% government funding, investing in an accounting apprenticeship with ICAEW will strengthen your finance function and build a pipeline of future professionals.

This route into chartered accountancy provides new or existing employees, of any age, with the knowledge, skills and experience that your business needs now and to grow in the future. Taking on apprentices in accountancy can be a cost-effective way of developing and growing your finance team.



ASSESS YOUR BUSINESS NEED

We offer two apprenticeship programmes, both of which incorporate our globally-recognised qualifications:

- The Level 4 Accounting Technician Apprenticeship includes the ICAEW Certificate in Finance, Accounting and Business (ICAEW CFAB) and your students will be eligible to apply for the BFP designation.
- The Level 7 Accountancy Professional Apprenticeship incorporates the 15 exams of the ACA, setting students well on their way to ICAEW Chartered Accountant status and giving you the option to offer the ACA on a government-funded programme.

Both apprenticeships are available to all employers in England, regardless of whether you're paying the apprenticeship levy or not.

FUNDING

The government provides apprenticeship levy funds for employers, incentivising you to train and develop new talent. This funding is available whether you are a levy or non-levy paying organisation, in business, practice or the public sector. The funding cap is £8,000 for the Level 4 apprenticeship and £21,000 for the Level 7 apprenticeship.

LEVY PAYING EMPLOYERS

All employers operating in the UK with an annual wage bill of more than £3m are charged a levy of 0.5%. You can use your levy money to buy apprenticeship training for employees at all levels and ages. The government applies a 10% top-up to monthly funds, so for every £1 you put in, you will have £1.10 to spend.

NON-LEVY PAYING EMPLOYERS

Employers who do not pay into the apprenticeship levy can access funding via a government-employer co-investment. Non-levy paying employers make a 5% contribution and the government will pay the remaining 95%, up to the maximum amount of funding set for the apprenticeship you have chosen. This means your 5% contribution will be £400 for the Level 4 apprenticeship or £1,050 for the Level 7 apprenticeship.

What does the funding cover?

The funding available to you will cover the costs for the end-point assessment, the training and the learning materials. For the training, you can choose which tuition provider you want to deliver your apprenticeship and agree with them how much you will spend on a tuition bundle. The student registration and annual fee, along with the on-programme exams or re-sits, are not eligible for funding. Learn more about what is covered for the Level 7 and Level 4 apprenticeships.





CREATE AN ACCOUNT

You will need to create an apprenticeship service account, which is a government service allowing you to set up and manage apprenticeships. The account will enable you to set up and approve apprentices, access and manage funding, approve training costs, and more.

SELECT A TUITION PROVIDER

Once you've created your apprenticeship service account you can choose a tuition provider to provide training for your apprentice. The tuition provider monitors a great part of the apprenticeship process and will help you review your apprentice's performance and ensure they are adhering to the off-the-job training requirements.
