From Premier League football clubs to huge multinational companies, chartered accountants look at how money flows in and out, measure the value of assets, and analyse how organisations are performing.



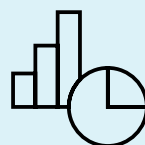

The ICAEW Associate Chartered Accountant (ACA) qualification is one of the most advanced learning and professional development programmes available. It is valued around the world in business, practice and the public sector. The knowledge and skills provided by the ACA mean that ICAEW Chartered Accountants are highly sought after professionals.

ICAEW CERTIFICATE IN FINANCE, ACCOUNTING AND BUSINESS (ICAEW CFAB)

ICAEW CFAB is a qualification that teaches essential knowledge in finance, accounting and business, and it is recognised by organisations worldwide. Made up of the first six modules of the ACA, ICAEW CFAB will teach you skills that will be useful throughout your working life, and the qualification can be the first step towards a career as an ICAEW Chartered Accountant.

ICAEW BUSINESS AND FINANCE PROFESSIONAL DESIGNATION (ICAEW BFP)

ICAEW CFAB is also a stepping stone to the ICAEW Business and Finance Professional (BFP) designation. BFP provides you with professional status, recognises your achievements, and supports you with your development as you progress in your career. Demonstrating your ability to stay up to date in your profession, BFP is evidence of a strong understanding of ethics and a commitment to professional development.

There are three integrated elements to ACA training.



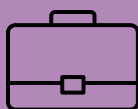
BUSINESS, FINANCE AND ACCOUNTANCY EXAMS

These exams will equip you with the professional skills you need to excel in the modern workplace.



SPECIALISED LEARNING

Tailor your learning, completing a minimum of 30 units of Specialised Learning from a wide range of interactive e-learning content.



PROFESSIONAL SKILLS AND EXPERIENCE

Put what you learn into practice as you record at least 450 days of relevant 'on-the-job' work experience while developing key transferrable skills.

THE EXAMS

With a 'step-by-step' approach that supports you to succeed, the ACA equips you with in-depth knowledge across a range of topics in business, finance and accounting. You'll be assessed through 14 computer-based exams which can be taken at an exam centre or remotely, and are split across three levels:

- **Certificate Level:** Sustainability and Ethics; Accounting Fundamentals; Assurance and Risk Fundamentals; Business Law; Tax Fundamentals; Business Insight and Performance.
- **Professional Level:** Fundamental Case Study; Assurance, Risk and Reporting; Corporate Reporting, Data and Assurance; Business and Digital Strategy; Corporate Financial Strategy; Tax Compliance and Planning.
- **Advanced Level:** Technical Case Study; Strategic Case Study.

KEY THEMES: SUSTAINABILITY, TECHNOLOGY AND ETHICS

Over the next decade, sustainability, technology and ethics will be the three key themes impacting every accountant and business they serve. All three have been integrated throughout the ACA, guiding you to become a forward-thinking business leader ready for tomorrow's world.

HOW TO BECOME CHARTERED

To become an ICAEW Chartered Accountant you must complete 450 days of on-the-job training alongside the study elements of the ACA qualification.

To do so you will need to secure a training agreement with a company or accountant authorised by ICAEW. The training agreement will outline the support you'll receive during training and will include details about tuition, study leave and mentoring.

As well as offering study leave, employers will usually pay for your tuition with a dedicated provider, and also pay for your exam and student registration fees. You'll need to complete the ACA qualification before you can apply to become a member of ICAEW.

OTHER ROUTES TO CHARTERED ACCOUNTANCY

You can also study the ICAEW Certificate in Finance, Accounting and Business (ICAEW CFAB), a standalone qualification that covers the first six modules of the ACA.

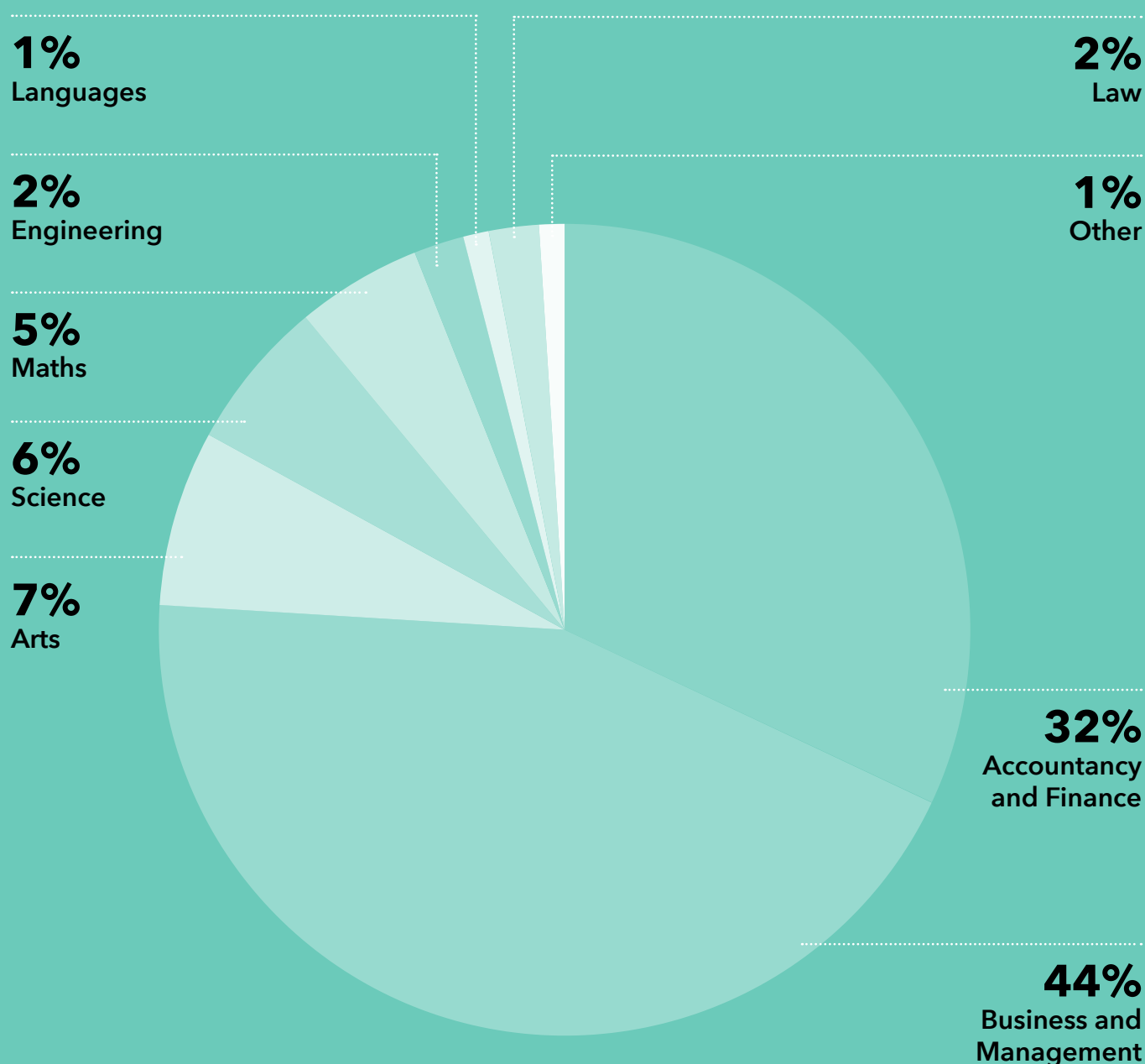
TRAINING AS AN INDEPENDENT STUDENT

If you've not been able to secure a training agreement, but want to take steps to qualifying as an ICAEW Chartered Accountant you are able to register as an independent ACA student. You will still need to complete the required work experience and professional development with an ICAEW Authorised Training Employer, but you will have the opportunity to start studying the ACA and take exams.
