With its focus on professional scepticism and everyday business challenges, Without Question is designed for use by firms and companies of all sizes, and all around the world, including:

Without Question draws out many themes for discussion such as reliance on experts, accounting estimates and confidentiality. It also examines conflicts within a family-owned company, its difficult transition to become a listed entity and the struggle of founding shareholders with the loss of control and of new independent directors in asserting control and good governance.

The last thing he needs is for Karen Walker, Rapston's FD, to pursue an aggressive tax relief claim championed by a rival firm (while also at the same time undertaking Rapston's first foreign hotel development). Poor Will doesn't realise he's also in for a big wake-up call on the dangers of social media ...

It has been used at many international accounting firm conferences and directors' events around the world to coach thousands of auditors and directors.
