ICAEW BASE 2017 COMPETITION



TERMS AND CONDITIONS OF ENTRY

These are the terms and conditions upon which each Entry to the ICAEW BASE Competition 2017 shall be subject. If the BASE Competition ("we", "us", "our", "ICAEW", "Competition", "BASE Competition" "BASE Heat" or "BASE") accept an entrant's ("you", "your", "team" or "entrant") Entry, you will be bound by these terms and conditions and your Entry shall be accepted in accordance with these terms. We reserve the right to amend these terms and conditions at any time and such changes shall be deemed notified to you by their publication online.

Definitions

The following terms shall have the following meaning in these terms and conditions:

- 'Administration Fee' means the right to levy a fee in event of cancellation of your entry into the BASE Competition if that cancellation occurs within two weeks of the date of your chosen Heat.
- 'Closing Date' means the dates specified on the Website in relation to the Competition.
- 'Entry' means your entry submitted to the BASE Competition on the site.
- 'Judges' means the judging panel at each Heat which will comprise three ICAEW Chartered Accountants for every ten teams participating at each Heat.
- 'Heat' means each particular heat date as particularly listed and detailed on the Website.
- 'Website' or 'the site' means the BASE website accessible at www.icaew.com/base.
- 'National Final' means the final of the competition to which the winning team from each Heat will be invited to represent their region.

BASE Competition Entry Formalities

All Entries must be submitted in the English language via the online entry form on the Website, or via a hard copy registration form downloadable from the Website. Each Entry must be submitted to the BASE Competition in accordance with these terms and conditions. By submitting an Entry you confirm that you accept these terms and conditions and you have the agreement of all parties associated with the booking of your team(s) at a BASE Heat that the submission be made.

Each Entry must be received by ICAEW on or before the Closing Date. Entries received after the Closing Date will be only be considered by ICAEW at their discretion.

In the event that an Entry is inaccurate or incomplete, does not comply with these conditions for entry or is deemed, at the sole discretion of ICAEW, ineligible for any other reason, then the relevant Entry will not be accepted.

The Heats will take place between November 2016 and March 2017 with the winning team form each Heat being taken forward to the 2017 BASE National Final (Date to be confirmed).

ICAEW reserves the right to levy an administration fee in the event of cancellation, by you, of your Entry into a BASE Heat if such cancellation is made within two weeks of your chosen Heat date.

Number of Entries

You may submit a maximum of two team Entries at one single Heat date to the BASE Competition, this will depend on availability and spaces for second teams will only be allocated a maximum of six weeks prior to a heat. Priority will always be given to teams from additional schools/colleges.

Judging Entries

Teams will be judged on the day of each Heat against specific judging criteria which will be used consistently at each BASE Heat.

BASE Competition Judges will determine a winning team from each Heat to go through to the National Final of the BASE Competition 2017. Winners of each Heat will be announced on the day of the Heat and will be published on the Site within 5 working days of the Heat taking place. The decision of the judges at each Heat will be deemed as final and neither ICAEW or individual Judges will not enter into any correspondence or discussion with any Entrants on any subject nor will ICAEW or the individual Judges accept any submissions or representations or appeals with regard to such decisions, and BASE Competition reserves at its sole discretion the right to disqualify Entries which do not comply with these conditions or for any other reason.

Confidentiality

Your entry will not be considered as confidential and you agree that ICAEW can make mention of your Entry and your attendance at your selected Heat for the purposes of promotion and marketing. You agree to gain permission, from your students and/or their parents/guardians, for the taking of photographs and filming at your chosen Heat for the purposes of ICAEW's promotion of the Competition to other schools/colleges and in its engagement with commercial partners.

Limitations & Disclaimer

ICAEW accepts no responsibility, financial or otherwise, for:

- any promise or indication made public before an winner of the Heat is formally announced
- any damage whatsoever caused by any actions taken by ICAEW in relation to any particular Entry or Heat

In no event shall the BASE competition, or ICAEW, be liable whether in contract, tort, by statute or otherwise in respect of any loss of profits and/or loss of business for any special, indirect, incidental or consequential loss or damage arising out of or in connection with the BASE Competition, including without limitation: loss of revenue, loss of anticipated savings, loss of business and/or goods, loss of goodwill, loss of use, loss and/or corruption of data and/or other information.

Nothing in these terms and conditions shall exclude or restrict our liability for fraudulent misrepresentation and/or for death or personal injury to the extent that such injury results from our negligence or wilful default.

For the avoidance of doubt, entrants agree and accept that they will be solely responsible and liable for any and all damage caused by their Entry.

If your entry wins a Heat

You will be informed whether your Entry is the winning team on the day of the Heat. The winning Entry from each Heat will gain a place at the BASE 2017 National Final and further details of the arrangements for the participation in the National Final will be provided to the winning team at the end of each Heat.

For winning teams travelling to the National Final, the BASE competition will consider contributing, at its discretion, to reasonable travel costs.

Using your personal information

We will treat your personal information in accordance with data protection legislation. We will use your information for administration, communication and research. To do this we will share your information with our business partners.

We may transfer your information outside the European Economic Area (EEA) eg, to one of our offices. These countries may not have similar data protection laws to the EEA, so if we do transfer your information we will take the necessary steps to ensure that your privacy rights are still protected.
