

ICAEW Economic Insight 2018: South-East Asia Q2 Report Launch Event

As one of ICAEW's flagship events, the Economic Insight 2018: South-East Asia Q2 Report Launch was hosted in Vietnam and Singapore in the month of June. Sian Fenner, Lead Asia Economist at Oxford Economics and ICAEW economic partner, presented the Q2 report on the latest economic trend in ASEAN. This was followed by a panel discussion around the topic on how global trade policies impact on local businesses, changes to economic trends that influence the Vietnam economy, and the preparedness of accountancy professionals in tackling technology and the new form of currency.
